Council Meeting Synopsis:

December 13, 2011: A public hearing to discuss the 2012 Village of Bellevue Budget was held at this meeting. Following the public hearing and discussion by the council the budget was adopted. Amendments to the 2011 budget were also introduced for discussion with action to be taken at the next meeting.

Updates were given on the Washington Park Project and the possibility of having a cell tower on the Village's water tower. The most recent information that has been shared with the Village by Verizon is that there is the possibility of this being a 1st Quarter 2012 project. Agreements need to be finalized and plans approved first.

The council also discussed a parking spot on W. Jackson St. and its removal to allow for easier egress and ingress of the emergency services vehicles and they set 2012 meeting dates.



December 27, 2011: The council handled five agenda items at their regular meeting on December 27. These were the amendment of the 2011 Village of Bellevue Budget, making appointments to the Bellevue Joint Planning Commission, setting the salaries and wages of the Village employees, approving a contract for the Village Manager, and adopting the Village of Bellevue Cooperation, Collaboration, and Consolidation Plan.

The Village of Bellevue Cooperation, Collaboration, and Consolidation Plan is a plan written to comply with State regulations. Its completion and submittal to the State will allow the Village to qualify for stage two of the Economic Vitality Incentive Program (EVIP) funding for local governments.

The Village Council will meet on the second and the fourth Tuesday of each month in 2012 except December, when they will only meet once, on the second Tuesday.
