H. Coy moved to appoint Don Malinowski to the vacant Planning Commission seat, seconded by B. Balkema. Motion carried.

Jim Mott updated the council on the parks grant, which will be open for applications through March or April of 2024; Eaton Co. is also getting bids to finish the Dyer Kiln stonework. The council discussed moving the December 12<sup>th</sup> meeting date to the 19<sup>th</sup> and not having a meeting on the 26<sup>th</sup>. They also discussed the vacant parcel #131-028-400-122-01 on E—Capital Ave. and that the Village will take over ownership on Dec. 30<sup>th</sup>, 2023. N. Roberts will send letters to residents who own property touching 300 S. Elizabeth St. stating that the council will discuss the requested variance at the Dec. 19<sup>th</sup> meeting.
