L. Pfiester moved to allow N. Roberts to reallocate funds within the 2024 General Fund to ensure that no departments are over budget, seconded by H. Coy. Motion carried.

B. Balkema moved to increase the Water rates by \$1.53 per 1,000 gallons to \$6.75 per 1,000 gallons and the base rate by \$6.12 to \$34.92 effective immediately. The Sewer rates of \$15.54 per \$1,000 gallons and the base rate of \$62.40 are to remain the same, seconded by L. Pfiester. Motion carried.

S. Roberts moved to adopt the 2025 Annual Budget as written, seconded by H. Coy. Motion carried.

L. Pfiester moved to change the council meeting times to 6:00 p.m. starting in January 2025, seconded by J. Willis. Motion carried.

L. Pfiester moved to amend the agenda by adding vacation hours for K. Singh, seconded by H. Coy. Motion carried.

H. Coy moved to allow K. Singh to roll 13 hours of vacation time to 2025, seconded by S. Roberts. Motion carried.

H. Coy moved to adjourn the meeting at 8:06 p.m., seconded by S. Roberts. Motion carried.
