- S. Roberts moved to change the Police Chief's wages from a salary position to an hourly position effective immediately, seconded by R. Spaulding. Motion carried.

The council discussed the possibility of a village-wide garage collection on the August 2024 ballot and having N. Roberts also put notices in at least two newsletters before the election, notifying the residents that it will be on the ballot. They also discussed new wording for the Fire Control Board Contract 2024 and possible wage increases for village employees for 2024 if it can be budgeted. The council is also impressed with the job that the DDA has been doing trying to revitalize downtown and with community events.
