J. Mott was here from Eaton County and discussed the Public Safety Millage that will be on the ballot in May. If it passes, the county will have 24/7 road coverage and fund the prosecuting attorney's office and animal control. The county is tearing out the boardwalk at the Kheene Environmental Center because it continues to be vandalized; they plan on putting in additional trails from the Williams St. side and hope to deter people from going to the cement factory ruins. The council is continuing discussions about the Fire Control Board and what that looks like for the Village. L. Pfiester will send N. Roberts and M. Pennington some literature on Potentially Dangerous Taxpayer Training.
